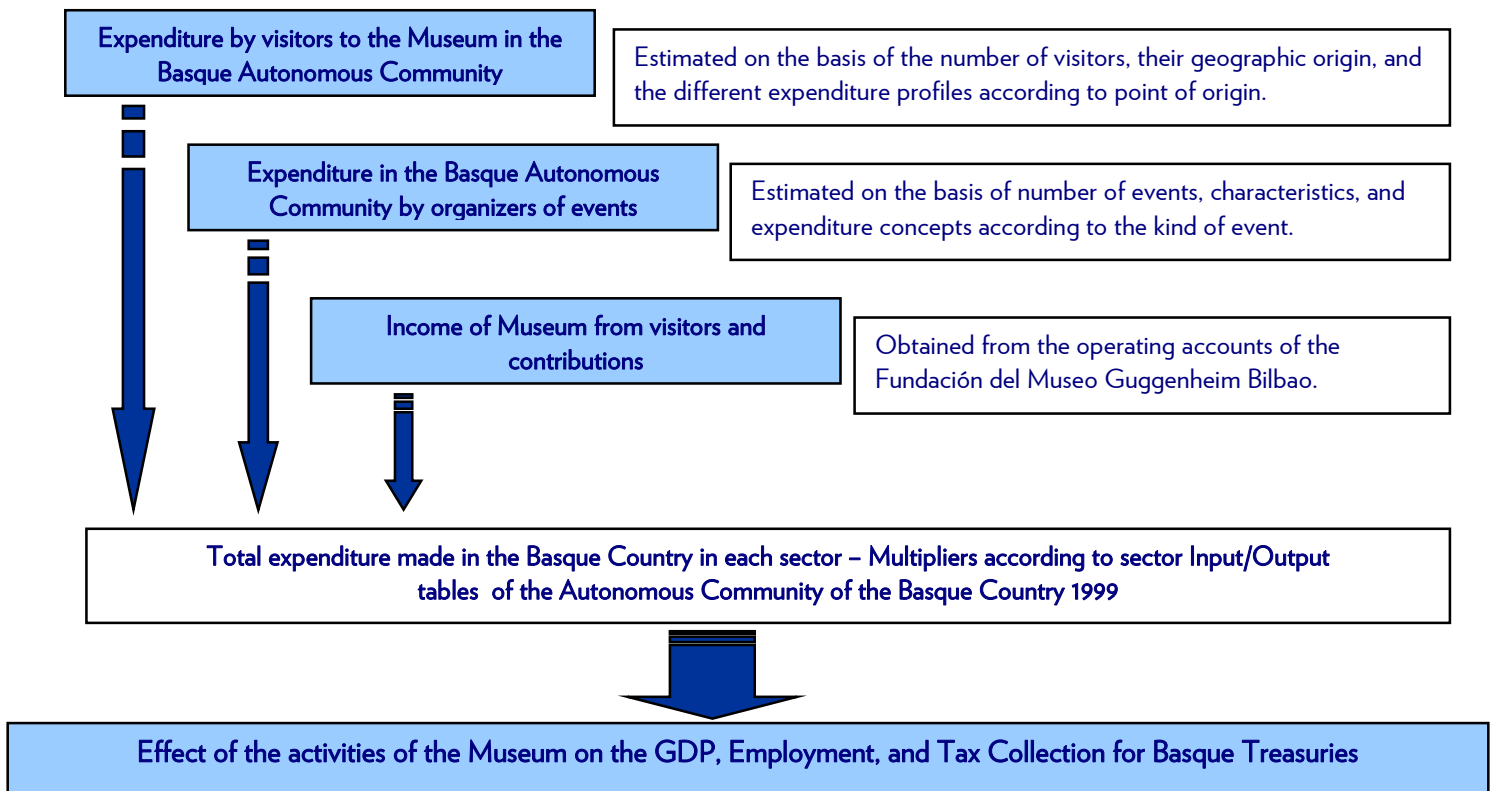
Impact of the activities of the  
Guggenheim Museum Bilbao in the  
economy of the Basque Country  
during the year 2005

## Introduction

In 1998 the Guggenheim Museum Bilbao asked a specialized consulting firm to draw up a macroeconomic survey model to assess the impact of the Museum activities in terms of wealth for the Basque Country. Since then the Museum has amended the results of the survey each year to bring them up to date and in 2001 new analytical elements were incorporated in it:

- Consideration of the induced effects.
- Inclusion of the direct expenditure made by several different companies and institutions that hold events in the Museum by hiring Museum spaces.
- Review of the expenditure profiles of visitors in accordance with their points of origin, including a new concept of leisure expenditure.
- The application of specific multipliers for each sector: retail, catering, transport, recreational and cultural activities and other business activities.

## Main results of the Impact Model

The main conclusions of the economic impact analysis of the activities of the Guggenheim Museum Bilbao during the year 2005 are highlighted in the following aspects.

The total direct expenditure generated by the activities of the Museum in the Basque Country amounted to 165,835,281 Euros, which represents an average expenditure of 171,84 Euros per visitor. The total direct expenditure is obtained from the sum of the following concepts:

1. 139,366,854 Euros that correspond to expenditure made outside the Museum as shown by the expenditure profile resulting from the survey.  
The sectors that have benefited most from the development of the activities of the Museum were:
  - Catering: 44,691,942 Euros in restaurants, bars and cafeterias.
  - Shopping: 17,790,343 Euros in stores.
  - Accommodation: 55,916,605 Euros in hotels, guesthouses and other kinds of accommodation.
  - Transport: 11,902,364 Euros in car hires, gasoline, tolls, tickets, etc.
  - Leisure: 9,065,599 Euros in cinemas, theaters, visits to other museums, etc.
2. 9,225,000 Euros that correspond to the expenditure of visitors inside the Museum: admission fees, guided tours, purchases in the Store-Bookstore, and expenditure in the cafeteria and restaurant.
3. 16,196,209 Euros that correspond to the expenditure of companies and the contributions of Individual and Corporate Members, Government grants, contributions, and other income.
4. 1,017,218 Euros corresponding to direct expenses deriving from the organization of special events in the Museum.

Considering the direct, indirect, and induced effects, the activities of the Guggenheim Museum Bilbao during the year 2005 have represented the generation of 186,197,551 Euros of GDP, additional income for the Basque Treasuries of 29,810,227 Euros, and have contributed to maintaining 4,893 jobs.

The impact of the activities of the Guggenheim Museum Bilbao on the Autonomous Community of the Basque Country from 1997 to December 31 2005 is set out below:
